Dear Parents,

For P1 students, all transferred students, individual students without Form B provided by the EDB or those with items requiring amendment (i.e. Name in English, Name of Day-school or School Level):

1. Parents/guardians should use Form A for the application.
2. In completing the application form, parents/guardians may refer to the attached document (Common Bank Code List), the reference information (including how to fill in bank account information correctly) uploaded onto the EDB website (<http://www.edb.gov.hk> > Students and Parents Related > Support and Subsidies > Student Grant).
3. Application forms returned on or before 3rd October will be sent to the Education Bureau within 7 working days.

The completed application forms must be submitted through our school. Only one application can be submitted for each eligible student. Applicants should read carefully the “Notes to Complete this Form” and the “Declaration” before completing the “Student Grant” Application Form.

Applicants are not required to provide other documents at this stage but will be required to do so when necessary. The EDB will contact parents via SMS or email to inform them of the status of their applications. The subsidy will be disbursed to parents via local bank transfer.
